### GENERAL INFORMATION

ORO-RZ is a wetting adjuvant for distributing soil-applied pesticides and nutrients in the root zone of plants. It is also an effective adjuvant when used in burndown and desiccation herbicide applications. ORO-RZ is a WSDA-registered material for use in organic agriculture when combined with other organic pesticides and nutrients.

- Improves the distribution of a tank mix solution within the soil profile.

### DIRECTIONS FOR USE AND PRECAUTIONS

Prior to use, read all the directions on this label and on the label of the manufacturers' insecticides, miticides, fungicides, herbicides, plant growth regulators and/or nutrients being used with this product. The manufacturers' label for specific usage and restrictions has precedence over directions for use referred to on the ORO-RZ label. Test for compatibility prior to mixing and application with other chemicals. Always test new tank-mix combinations before widespread use. If unsure, check with the manufacturers or contact your local State Extension Service if you have questions. To ensure thorough mixing, it is suggested that you recirculate mini tanks and bulk tanks or shake containers before using. Pre-rinse all tanks, spray lines or containers thoroughly before adding ORO-RZ as ORO-RZ contains surfactants. ORO-RZ should not be added to tanks, spray lines, or containers which may contain additional surfactant adjuvants. Residues in tank and spray lines, from previous chemicals sprayed, may be dissolved by ORO-RZ.

#### FOR SOIL

- In-furrow at planting with soil pesticides - Use 1 to 2 pints per acre
- In pre-emergent herbicide sprays - Use 1 to 2 pints per acre
- In broadcast tank mix solutions - Use 1 to 4 pints per acre
- **Chemigation:** (Through irrigation systems such as drip, microjet, sprinklers or pivot) - Use 1 to 8 pints per acre

**IMPORTANT:** Additional Operating Instructions for Chemigation. Review your state and local regulatory requirements before applying any adjuvant or agricultural chemical through an irrigation system. - 8 to 64 fluid ounces per ton of media (test rates prior to use)

#### FOR FOLIAR APPLICATIONS

- Burndown and Desiccation: Use 8-64 ounces per acre in a tank-mix of foliar- and soil-applied materials.

### APPLICATION DIRECTIONS

ORO-RZ can be applied in-furrow, flood, microjet, sprinkler and other irrigation systems. It can also be applied in conjunction with most types of liquid fertilizer. In addition, it can be applied as a soil spray. To reduce application trips, a foliar pesticide/desiccant can be added to an ORO-RZ tank mix. When metering ORO-RZ directly into an irrigation system by means of a metering injection pump or suction regulated line, do not connect to an irrigation system used for chemical applications or directly to a public water system without a back siphon prevention system in place. Always connect to such systems in accordance with local and/or state regulations.

### STORAGE AND DISPOSAL

**PROHIBITIONS:** Do not contaminate ponds, waterways, ditches and food or feed with chemicals and/or used containers by storage, disposal or cleaning equipment. **STORAGE:** Keep away from heat, sparks and open flame.
