## DOSAGE RATES

### FOR BEST RESULTS

- AGRICULTURE - Use 1 Pint to 1 Gallon per Acre
  - FAIRWAYS, LAWNS AND GREENS - Use 1 Pint to 1 Gallon per Acre.
- For improved water penetration, after pre-irrigation / leaching, TRANSFORMER can be applied through irrigation equipment.

## DIRECTIONS FOR USE AND CAUTIONS

Prior to use, read all the directions on this label. Pre-rinse all tanks, spray lines or containers thoroughly before adding TRANSFORMER as TRANSFORMER contains surfactants. TRANSFORMER should not be added to tanks, spray lines, or containers which may contain additional surfactants. Coatings on inner tank and spray lines, from previous chemicals sprayed may be dissolved by TRANSFORMER.

TRANSFORMER can be applied through furrow, flood, drip, micro-jet, sprinkler jet and other irrigation systems. It can also be applied in conjunction with most types of liquid fertilizer. In addition, it can be applied as a soil spray. When metering TRANSFORMER directly into an irrigation system by means of a metering injection pump or suction regulated line, do not connect to an irrigation system used for chemical applications or directly to a public water system without a back siphon prevention system in place. Always connect to such systems in accordance with local and/or state regulations. Early spring applications are more effective followed by repeat applications as needed.

## STORAGE AND DISPOSAL
